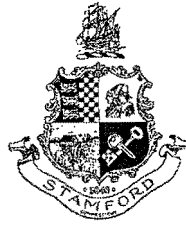

#### **Monthly Report**

A brief discussion was held regarding a roof leak in the Blue Room.


**New Business**
