ELIGIBILITY REQUIREMENTS

- ❖ All applicants must be 65 as of 12/31/21 or receiving social security disability benefits and over age 18
- persons on disability must have current proof of disability, i.e., a TPQY from social security clearly indicating "disabled individual"
- have resided in the state of Connecticut for one full year at some time in your life
- * be a resident of the state at the time of application.
- * 2021 income must not exceed \$38,100 for a single person, \$45,100 for a married couple
