COMMITTEE REPORT

Introduction:

The Appointed Boards & Commissions Committee was appointed in the Summer of 2022 by the Co-Chairmen of the full Commission. Its members consist of Commissioners Larobina, Bilicznianski, Lane, Bowser and Kolenberg. It was assigned with the responsibility of examining the charges from the Board of Representatives related to appointed boards and commissions. The Committee met a total of nine times beginning in August of 2022 and ending in March of 2023 (meeting minutes are attached as Exhibit A).

Discussion:

Initially the Committee met to decide which of the items from the Board of Representatives charge it would consider. Nine items from the charge were examined. It was concluded that five of the nine would be considered and four were initiated by the Committee for a total of nine:

- 1. Creating a board or commission on disabilities; (charge 41)
- 2. Creating a board or commission on Diversity, Equity and Inclusion; (initiated by Committee)
- 3. Revising Charter process for appointment to boards and commissions; (charge 46 and 47)
- 4. Examining the need for a commission on aging; (charge 43)
- 5. Review Social Services Commission; (initiated by Committee)
- 6. Review Health Commission; (charge 66)
- 7. Creating a board or commission on housing (initiated by Committee)

- 8. Designating some boards and commissions by Charter but allowing them to be amended by ordinance. (Initiated by Committee)
- 9. Review Parks and Recreation Commission (charge 67)

Item 1: Commission on Disabilities (Charge 41)

The Committee looked at commissions on disabilities from the City of Bridgeport, Town of Westport, City of Danbury, Town of Berlin and Town of Fairfield.

<u>Item 2</u>: Commission on Diversity, Equity and Inclusion (Initiated by Committee)

This item was not in the original charge. It came about as a result of our discussions on disabilities and social services. At the suggestion of our outside legal counsel, the Committee examined the DEI commission of the Town of Hamden. The City of Stamford's DEI officer also made a presentation on the topic.

Item 3: Appointments Process to Boards & Commissions (Charge 46 and 47)

After review of the current Charter provisions and reviewing the charge, the issue came down to one item; board and commission members continuing to serve beyond their stated term. The Committee reviewed the current language in detail and edited the current language.

Item 4: Commission on Aging (Charge 43)

The Commission on Aging was created by ordinance; not Charter. It was Article III Sec. 6-12 through 6-15 of the Code of Ordinances. In 2001, the Board of Representatives repealed the ordinance (Ordinance No. 959). When they repealed it, they merged the responsibilities with the Social Services Commission. Then in 2004 it was enacted again by ordinance (Ordinance No. 1017). In conjunction with the discussion on the Social Services Commission had by this Committee the topic of whether or not a Charter mandated Commission on Aging was in order. The director of the Stamford Senior Center was interviewed.

<u>Item 5</u>: Social Services Commission (Initiated by Committee)

The Social Services Commission was extensively reviewed. The City of Stamford's director of social services was interviewed and provided an overview of the responsibilities of her office. It was overwhelming obvious to the Committee that the office is under funded and under staffed. As much as the Committee took notice, it was also acknowledged the structure and organization of the social services commission can do little to address the resources needs. This is a budgetary issue for the City administration to address.

Item 6: Health Commission (Charge 66)

The current health commission language was examined along with an interview of the City of Stamford's director of health. The various roles of the health department were discussed and the impact it has on the residents of the city. Also discussed was the educational and professional experience of members of the health commission.

<u>Item 7</u>: Commission on Housing (Initiated by Committee)

The issue of a housing commission grew out of discussion from the February 25, 2023 full Commission meeting. Several Committee members also expressed the need for a commission dedicated to housing. Specifically, the issue of affordable housing within the City of Stamford.

<u>Item 8</u>: Boards & Commission by Charter vs. Ordinance (Initiated by Committee)

This item grew out of a recommendation from outside counsel. The issue is mandating some boards and commissions by charter and also proscribing their composition and duties. In the alternative mandating they exist but give the Board of Representatives the ability to amend by ordinance their composition and duties.

Item 9: Parks and Recreation Commission (Charge 67)

The current Charter provisions with respect to the Parks and Recreation Commission were reviewed. During this process it was discovered that the current Charter reserved to the Board of Representatives the authority by ordinance to amend this section of the Charter. Therefore, it was the consensus of the Committee to defer to the Board of Representatives if changes are needed and/or are appropriate.

Recommendations:

With respect to *Item 3*, it is the Committee's recommendation to put forth edit changes as delineated in Exhibit B attached. Vote: Consensus

With respect to **Item 4,** there is no recommendation to mandate by Charter a Commission on Aging. While the Committee recognizes the need and importance it can serve, it was determined that there are outside agencies that serve the needs of senior citizens. Those agencies are in need of more support, but this is a resource issue outside of charter revision. Article III, Section 6-12 Code of Ordinances commission exist per ordinance. Vote: 4-0-0.

With respect to *Item 5*, it is the Committee's recommendation to put forth edit changes as delineated in Exhibit C attached. Vote: 4-0-0

With respect to *Item 6*, it is the Committee's recommendation to put forth edit changes as delineated in Exhibit D attached. Vote 4-0-0

With respect to **Item 8,** it is the Committee's recommendation to make no changes to the current Charter. Vote: 4-0-0

With respect to *Item 9,* it is the Committee's recommendation to defer to the Board of Representatives. Vote: 4-0-0

With respect to *Items 1, 2 and 7,* it is the Committee's recommendation to create two commissions. The first would be a Citizens Oversight and Social Responsibility Commission. This

commission would be responsible for making recommendations to the Board of Representatives on matters of disability and diversity, equity and inclusion. This commission would also have investigatory powers to oversee all city departments and agencies and hear citizen complaints. The initial proposal included housing in this commission. After discussion, it is the recommendation to create a separate housing commission. In addition, the fair rent function would be merged into the new housing commission. This will reduce the work load of the social services commission and the social services department (see Exhibit E for proposed language). Vote: 4-0-0

Agenda Item Number 3:

Discussion continued on the creation of a commission on disabilities. The Committee examined the commission on disabilities from the Town of Berlin, Town of Fairfield, City of Bridgeport, Town of Westport and City of Danbury. Agenda Item Number 3:

The first person to address the Committee was the director of the Stamford Senior Center, Christina Crain. She informed the Committee that there are 30,000 citizens over the age of 60 in Stamford. The Stamford Senior Center is the smallest in Fairfield County and receives the smallest amount of financial contribution from the City. Currently there is no Commission on Aging. Ms. Crain was of the opinion that there is value in a commission since seniors are underrepresented. Discussion centered around the advisory role of a commission.

The second person to address the Committee was the health director, Jody Pullan. She informed the Committee that the health commission serves in an advisory capacity and she meets with them on a regular basis. She finds the interaction with the commission helpful. She stated she feels it is important for at least a few members of the commission to have a health background. She pointed out that the commission hears appeals from orders of the health director, housing code enforcement and food establishment appeals.

The third person to address the Committee was the director of social services, Sharona Cowan. The discussion centered on the issues with obtaining a quorum of the social services commission and like the health commission the qualifications of the individuals who serve. Discussion was also had about the broad responsibilities of the commission and possibly moving some of those responsibilities to another commission allowing the social services commission to focus on the core functions of the department.

The Committee adjourned at 5:15 pm upon motion made by Commissioner Lane, seconded by Commissioner Kolenberg and passed unanimously.

Agenda Item Number 5:

After lengthy discussion, in a vote of 4 in favor, 0 against and 0 abstentions the Committee is making a recommendation to the full Commission to create a Social responsibility Commission with jurisdiction over DEI and Disability. A separate commission on Housing and Fair Rent. Both of these commissions would be appointed by the Board of Representatives and make recommendations to the Board of Representatives.

Sec. C6-00-3 - Appointment and Removal.

The Mayor shall many submit to the Board of Representatives, at its first meeting after its organizational meeting, nominations of members to each appointive Board, Commission or other similar appointive position, to fill each vacancy where a term of office has expired. The Mayor shall also submit to the Board of Representatives at such meeting nominations of alternate members of the Planning Board, the Zoning board and the Zoning Board of Appeals to fill any vacancies on a "panel of alternates" where an alternate member's term of office has expired. No nomination to such appointive Boards, Commission, positions or "panel of alternates" made by the Mayor shall become effective until approved by the Board of Representatives. Provided, however, if a nomination to any such appointive Board Commission, position or "panel of alternates" made by the Mayor shall not have been approved or rejected by the Board of Representatives for a period of ninety (90) day, then such nomination shall hereupon become effective, having been deemed to have been approved by the Board of Representatives through its inaction. Provided further, however, if the Mayor shall fail to submit a nomination to the Board of Representatives within on hundred and twenty (120) days after the expiration of a Board or Commission or alternate member's term of office, the, at any time during the one hundred and twenty (120) day period thereafter, the President of the Board of Representatives was shall be required to nominate and the Board of Representatives approve a successor to fill the position. Previded further, however, if said Seard of Representatives shall fail to act within the allotted time period, the Mayer shall again be empowered to nominate an individual to fill the vacancy and the Board of Representatives shall have ninety (90) days to approve or reject such nomination as set forth above.

SUBDIVISION D. RESERVED CITIZENS OVERSIGHT AND SOCIAL RESPONSIBILITY COMMISSION⁶

Sec. C6-110-1. (Reserved) Appointment, Terms^T.

The Citizens Oversight and Social Responsibility Commission shall consist of nine (9) members to serve staggered/overlapping terms of three (3) years, to be appointed by the P(resident and approved by the Board of Representatives.

Sec. C6-110-2. (Reserved) Powers and Duties of the Citizens Oversight and Social Responsibility Commission⁸.

In furtherance of the investigatory and oversight functions of the Board of Representatives, the Citizens Oversight and Social Responsibility Commission shall act as an independent and impartial commission empowered to exercise the following powers and duties:

(a) Citizen Oversight. (1) Review the acts of administrative agencies, departments and any authorities created by the Board of Representatives pursuant to the Connecticut General Statutes or tis Charter; and (2) recommend appropriate changes toward the goals of safeguarding the rights of persons and of promoting higher standards of competency, efficiency and equity in the provision of municipal services.

- (b) People with Disabilities. (1) Make recommendations to ensure Stamford is a welcoming community where people with disabilities can lead inclusive and fulfilling lives participating and contributing as active members of our city; (2) Provide advice to all city departments, board, commissions, agencies and authorities aforementioned, to increase awareness about issues and opportunities affecting people with disabilities; (3) Advise city officials on policies, procedures, programs and services including facilities; (4) Provide information and guidance to individuals, businesses and organizations on matters related to disabilities; (5) Engage people with disabilities and their families, encouraging them to participate in city government and planning; and (6) Foster and promote a community dialogue with businesses, community organizations, clubs and associations.
- (c) Diversity. Equity and Inclusion. (1) Make recommendations with respect to diversity, equity and inclusion in the operation of city government; (2) Coordinate efforts to gain public input into diversity, equity and inclusion principles, policies and approaches across all City policies, procedures and systems of the City; (3) Provide assistance to the Mayor. Board of Representatives and other Boards and Commissions with respect, but not limited, to the following issues: housing access to education, public health, law enforcement and civilian engagement and supporting participation in City Boards and Commissions and governance; and (4) Exercise the powers concerning the investigation and elimination of discriminatory practices pursuant to Sections 7-148i through 7-148n, inclusive, of the General Statutes³.
- (d) Fair Rent Commission Functions¹⁰. (1) Exercise all of the powers conferred by Sections 7-148b to 7-148f, inclusive, of the Connecticut General Statutes, as amended, and shall carry out the provisions of Section 47a-20 and Subsection (b) of Section 47a-23c of the Connecticut General Statutes concerning retaliatory action by landlords; and, (2) Act to control and eliminate excessive rental charges for housing accommodations within the City of Stamford and shall carry out the purposes, duties, responsibilities and all provisions of the above-described sections of the Connecticut General Statutes and any other sections, as they may be amended from time to time, pertaining to fair rent commissions.
- (e) Oversight of the Affordable Housing Plan ("SAHP"). Oversee the Stamford Affordable Housing Plan (SAHP) as provided for in Section 146-74 of the Code of Ordinances. In order to effectuate this provision of the Charter the Land Use Bureau shall report to the Commission bi-annually on the SAHP and shall take into consideration recommendations from the Commission to the plan. The Land Use Bureau shall not submit its plan as called for in Section 146-74 of the Code of Ordinance to the Planning Board without review and recommendations from the Commission.

Sec. C6-110-3. Reviews, Findings and Recommendations of the Commission¹¹.

- (a) Generally. Commission review shall mean an informal inquiry resulting in a written report to the Board of Representatives detailing the finding(s) and recommendation(s). Before submitted any findings or recommendations the Commission shall consult with the subject of the report whether a Department or individual and include their response in the report.
- (b) Subject Matter Panels or Subcommittees. The members of the Commission shall be assigned by the Chair to sit on three-member subject matter panels or subcommittees in order to conduct reviews and hearings with respect to the powers and duties of the Commission. Their recommendation shall be presented to an acted upon by the entire Commission prior to transmittal to the Board of Representatives.
- (c) Panels on Fair Rent Commission and Discriminatory Practice Functions.

 With respect to the Fair Rent Commission and discriminatory practice functions the members shall be assigned by the Chair to sit on five-member panels to adjudicate matters in accordance with the provisions of the General Statutes and Ordinance. Upon request, the Corporation Counsel shall provide legal representation for the Commission in these functions.

Sec. C6-110-4. Right of Access Public Records 12.

Any other provisions of law notwithstanding, the Commission shall have access to and examine and copy, without payment of a fee, any municipal or agency records. The Commission shall not have access to legally privileged records held by the Corporation Counsel, other assigned and authorized legal counsel for any municipal department or other authority, or attorney-client records held by clients of the Corporation Counsel or other legal counsel to the City.

Sec. C6-110-5. Finding of Breach of Duty or Misconduct¹³.

In the event the Commission concludes that a breach of duty occurred or that a public official or employee engaged in misconduct under Law, the Commission may refer the matter to the (a) Mayor; (b) appropriate department head; (c) the Board of Ethics; or, (d) when appropriate, to the Chief of Police, or any other law enforcement or regulatory agency. The Commission shall consult with the Corporation Counsel or assigned counsel in order to determine the appropriate balance of public disclosure, personal privacy and investigatory probity

Sec. C6-110-6. Code of Ethics Violation14.

It shall be a violation of the Code of Ethics for any individual or person to willfully (a) hinder, or, (b) refuse to cooperate with an investigation or review by the Commission.

Sec. C6-110-7. Funding

The Commission may submit at its discretion a request for operating funds directly to the Board of Representatives subject to its approval, to be paid from a dedicated line item in the Board of Representatives budget. The Mayor's budget shall include, and the Board of Finance and Board of Representatives shall appropriate for the support of the Commission and its employees at least the amount necessary to maintain the staffing level as approved in the previous annual budget, unless the Commission requests a lesser amount.

Sec. C6-110-8. Cooperation

Each Official and employee of any Department of the City shall assist the Boards and Commissions and the pertinent Departments in carrying out the provisions of this Charter. Furthermore, in the event a Board or Commission is attached to a Department, the Department Head shall cooperate with said Board or Commission in formulating and carrying out the operational, management and personnel policies of the Department.

Sec. C6-110-9. Reorganization and Restructuring 17.

The powers and duties of this Commission may be modified by Ordinance and assigned to another Board or Commission, subject to the limitation that all such powers and duties set forth in this Charter shall be continued to be provided to the residents of this City. Notwithstanding the foregoing, such power or duty may be modified or eliminated as the result of a repeal of a Federal or State mandate, if it is determined that to do so is in the best interest of the City.
