Circling back on this. I got the below feedback from Eagle Environmental on the submitted change order.

I have gone through our field records and have documented sixty three (63) loads of ACM building debris generated from the building demolition activities that match up against the manifests submitted by Stamford Wrecking. The manifest numbers match up against our field logs with the exception of one manifest that I could not find in Stamford's submittal package – Manifest number B-61801 is documented as having been issued on 6-22-2022 (this manifest number is included in my calculation of the 63 loads). I did not see this manifest in the submittal. We documented 63 loads leaving the site and their Change Order references 63 however they are missing the above noted manifest unless I missed it the 268 page submittal.

Eagle did not write the bid specifications for the project was not involved in any of the upfront bidding activities, contractual negotiations or bid award so we are at a loss to comment on the pricing aspect of the change order. Eagle was contracted to provide asbestos abatement monitoring and oversight services only. Our role was to strictly document how many loads of ACM debris were hauled off site as directed by Jeff Pardo. Furthermore, I do believe the reference to the unsuitable fill is not for asbestos building debris but rather for fill contaminated by some other source but not having authored the bidding documents I am at a loss to confirm this to be the case. This would be a question for BL Companies.

Based upon our review the total number of loads being quoted is correct. Please let me know if you have any other questions.

I guess we need to review and interpret rates etc. with what is called for in the contracts well as any scope that may have been eliminated if any by this disposal.

Thanks for meeting at the site yesterday afternoon.

The following is a recap of our discussion and what we agreed upon regarding additional ACM.

We agreed that additional asbestos would be calculated by subtracting the quantity of asbestos included in the specifications from the actual quantity of asbestos as verified by certified weight tickets.

The baseline quantity conversion is as follows:

Concrete Foundation Walls

Specified quantity – 2,650 SF x 1' Thick = 2,650 CF x 150 lbs.CF = 397,500 lbs / 2,000 lbs/ton = 199 tons

Dampproofing Behind Brick Walls

Specified quantity - 6,760 SF x 10" Thick = 5,633 CF / 27 = 209 CY x 1.3 Conversion = 272 tons

SWC is responsible for 471 tons of asbestos waste disposal. The City is responsible for the verified tonnage over 471 tons which will be applied to the disposal unit price approved by the City.

On 6/15/22 I sent you an email with my calculations regarding extras and deducts of non-friable ACM based on field conditions. Two of the foundations that were removed that do have ACM are not being removed. Eagle needs to know how those foundations are being considered. They are hampering your excavator's ability to continue working effectively. If you want to keep track of the foundations that will be additional to the contract and those that will be a deduct, we can do that easy enough.

Just so you know, your original schedule for Mass Demo (Uncontaminated Building Material), Mass Demolition (AWP Asbestos Waterproofing) and Mass Demolition Slab & Foundation (Uncontaminated Building Materials) had a duration

of 25 working days. Currently, building demolition began April 11th, including today, Stamford Wrecking is at 50 working days and the work may require an additional two weeks to complete, perhaps more. Any perceived delay Stamford Wrecking believes they encountered has nothing to do with these additional 25 days and counting for the mass demolition.

I need to get this project finished. I'm paying Eagle by the day and many of the days there is very little activity.

Photo 4-22-22 2 was the first time I thought of taking a photo from on top of the courthouse garage, this is 10 days into the Mass Demolition activity. Photo 5-13-22 1 is 25 days into the Mass Demolition activity. Photo 6-21-22 1 is this morning, 50 days into the Mass Demolition activity.
