CALL TO ORDER:

Mr. Newman called the meeting to order at 6:32 p.m. and introduced the Commission Members and staff present.

OLD BUSINESS:

➤ Bylaws and Rules of Procedure (*Discussed at the July 19, 2023 Meeting*): Follow-up discussion on the proposed amendments to Article V – Election of Officers - Section 2.⁴

Mr. Newman read into the record Section 2 with the discussed changes as follows:

Officers shall serve 12-month terms. Officers may run for consecutive 12-month terms; however, an officer may be removed from the Chairperson or Vice Chairperson position by a two-thirds vote from the majority of the then current Commission when previous notice has been given to the officer. A successor may thereafter be elected by the majority of the then current Commission for the remainder of said term. In the event of a resignation or removal of the Chairperson prior to the end of term, the Vice Chairperson shall serve in their capacity until the previous Chairperson's term expires. The earliest election for a successor Chairperson shall take place at the next meeting of the then current Commission after the resignation or removal of said officer. In the event of a resignation or removal of the Vice Chairperson prior to the end of term, an interim officer voted by the majority of the then current Commission shall serve in their capacity until the previous Vice Chairperson's term expires. The earliest election for a successor Vice Chairperson shall take place at the next meeting of the then current Commission after the resignation or removal of said officer.

The Commission discussed the changes to Article V - Election of Officers - Section 2 as presented at the July 19, 2023 meeting.

Mr. Tedder made a motion to approve the changes to Article V - Election of Officers, Section 2 as discussed at the July 19, 2023 meeting and read into the record at this meeting.

Seconded by Ms. Katz
