(FINAL) Minutes of the Historic Preservation Advisory Commission (HPAC)

Date: Regular meeting held Tuesday, June 6, 2023.

Location: Via Zoom

Present: David Woods, Chair; Barry Hersh (Arrived at 7:35 p.m.), & Rebecca Shannonhouse -

Commissioners.

Absent: Elena Kalman, Commissioner and Claire Fishman, Alternate.

(NOTE: Ms. Fishman has resigned from the Commission and this would have been her last meeting.)

I. CALL TO ORDER.

Mr. Woods called the meeting to order at 7:15 p.m. Mr. Woods stated he and Ms. Shannonhouse were the only Commissioners present and were still waiting for the other Commissioners to arrive and he would admit the others as they signed in.

Mr. Woods explained the agenda was light and none of the items required a Public Hearing. Mr. Woods then introduced the first item on the agenda.

II. Approval and/or Corrections to May 2, 2023 Meeting Minutes.

The Commission considered the minutes of the May 2, 2023 Regular Meeting. There were no comments or modifications recommended.

Mr. Woods stated the minutes were approved with himself and Ms. Shannonhouse voting to approve but as there was not a quorum present [three (3) Commissioners], the draft minutes could not be approved with two (2) votes as per Robert's Rules of Order. The May 2, 2023 Regular Meeting draft minutes will be *TABLED* to the July 11, 2023 meeting.

III. NEW BUSINESS.

A. 34 Fahey Street - American Typesetting Company.

Presenter: Judy Norinsky, President, Historic Neighborhood Preservation & Renee Tribert, Preservation Connecticut.

Mr. Woods introduced Judy Norinsky, President, Historic Neighborhood Preservation.

Ms. Norinsky, along with Renee Tribert, Preservation Connecticut, made a presentation and answered questions from the Commission.

After an extensive discussion, Mr. Woods **TABLED** this item to a future meeting.

IV. OLD BUSINESS.

A. 16 Remington Street - Critical Reconstruction.

Presenter: Dariusz Lesniewski, Property Owner.

Tad Rexmer, Architect, provided details on the updates to the plans discussed at the March 7, 2023 meeting for the reconstruction and answered questions from the Commission.

Ms. Shannonhouse stated she is unable to attend but would forward the invite if anyone else could attend. Mr. Woods stated he is available and would participate on behalf of HPAC.
