Elderly/Disabled Homeowner Property Tax Relief Programs - 2023 Grand List Application Deadline: May 15, 2024

Eligibility Requirements:

- Applicant (or spouse) must have been 65 years of age by December 31, 2023. Totally disabled persons, regardless of age, are eligible, but must provide current proof of disability.
- Applicant or spouse must have become the legal owner of the property for which tax relief is sought on or before October 1, 2023. Property must be the applicant's primary or legal residence. (Primary residence is defined as residency of at least 183 days for a calendar year). If property is in a Trust, a copy of the trust document is required.

• State of Connecticut Program

- Qualifying income must not exceed \$43,800 if unmarried, or \$53,400 if married.
- For married couples, income of both husband and wife must be counted in establishing qualifying income.

City of Stamford Local Program

- Applicant or spouse must have been real property taxpayers of Stamford for one year immediately preceding their receipt of tax benefits.
- o Qualifying income must not exceed \$91,800 if unmarried, or \$108,000 if married.
- Assets* cannot exceed \$400,000 for unmarried applicants or \$600,000 for married applicants
 exclusive of an allowance of up to \$1,000,000 off of the equity value of the residence for which the
 tax relief is sought.
- Applicants must have no past due real property or motor vehicle taxes owed to the City of Stamford unless they are participating in a City approved payment plan and are less than sixty (60) days past due on such payment plan.
- * The worksheet attached should be completed in order to determine the total assets as required for the City of Stamford Tax Abatement for Elderly & Disabled homeowners per City of Stamford Ord.1282 Supplemental.

Required Documents:

- Completed asset worksheet
- > A copy of your 2023 SOCIAL SECURITY STATEMENT (FORM SSA1099) If married, we will need both.
- A copy of your 2023 FEDERAL TAX RETURN (FORM 1040) IF YOU ARE REQUIRED TO FILE. (If there are Schedule 1 and/or Schedule E attached to Form 1040, we will need a copy as well.)
- ➤ IF YOU ARE <u>NOT</u> REQUIRED TO FILE FEDERAL TAX RETURN, COPIES OF PROOFS OF INCOME FOR 2023 (Including but not limited to wages, lottery winnings, taxable pensions, IRA's, interest, dividends, net rental income, Federal Supplemental Security Income, State of Connecticut public assistance payments, General Assistance, veteran's pensions, veteran's disability payments, and any other income not listed above)
