The public is invited to give input at a meeting of the Terry Conners Rink Committee on the following items:

- Suggestions on how to improve the operations at the Terry Conners Rink
- Ideas on how to fund capital improvements at the Terry Conners Rink, outside of the City's Capital Appropriations process
- If the City were to lease the Terry Conners Rink to a third-party operator, what factors are important to consider (for example – ice time for Stamford's High School teams)

Prior to the meeting, it is recommended that participants listen to the tape recordings from two public meetings that were held by the Board of Representatives Parks and Recreation Committee. During the July meeting, the operations and capital expenditures for Terry Conners Rink were reviewed in detail.
