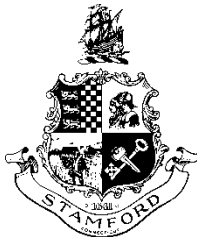

Failure to do so may subject the Bidder to disqualification.

All proposers are advised:

The proposal due date has been changed from May 2, 2024 to May 9, 2024.

The text on page 33 of 59 of the PDF regarding submission requirements has been revised. Proposers are advised we do not require an "A minimum of one (1) original and five (5) copies (along with two electronic – USB Drives) are required." All proposals shall be submitted via ProcureWare by May 9, 2024 at 4:00 PM. Proposals received after the date and time prescribed shall not be considered for contract award and shall be returned to the proposer. Neither mailed, faxed or emailed RFP responses will be accepted as qualified RFP submission.

Q: Who is the City's current broker for the coverages outlined in the RFP?

A: Arthur J. Gallagher & Co.

Q: If paid on a fee basis, what is the current broker's fee?

A: \$125,000 per year – fixed fee

Q: Could the City provide a schedule of insurance, that provides the carriers, limits, and retentions, to better help us understand the size and scope of the City's current program, and to appropriately set our fee?

A: Schedule follows.

Q: How come this RFP is being issued so close to the July 1st renewal?

A: Current agreement will terminate.

Q: Please advise if the City of Stamford utilizes CIRMA in any way.

A: We do not use CIRMA.

Q: Under the information requested for the Corporate Profile, the bidder's "Most Recent Annual Report" is requested. Can you provide more detail regarding what type of information the City is seeking in this annual report?

A: Please provide your most recent audited report and financial statements.
