The City originally entered into a Client Agreement with Morgan Stanley for these services in August of 2014. It later executed an Addendum to that Agreement in April of 2018 when Morgan Stanley was selected to continue these services via City RFP #725.

In July of 2021, the City executed another Addendum to the 2014 Client Agreement when Morgan Stanley was again selected to continue providing these services via RFP #820.

The City solicited another Request for Proposals No. 2024.0195 for these services in November of 2023. Morgan Stanley was again selected to continue providing these services, with the attached being another Amendment to the original Client Agreement with Morgan Stanley entered into in 2014. This Amendment revises the Scope of Services, Compensation and Term of the Agreement. The Scope of Services shall be as set forth in the City's RFP 2024.0195 and Morgan Stanley's Proposal thereto. The estimated annual fee for these services is \$161,000 (0.070%) based on a \$230,000,000 portfolio. The term will be for three (3) years with two (2) additional, one-year periods provided that all other terms of this Agreement remain the same. No such extension shall be for greater than one (1) year and, under no circumstances, shall the entire Term of this Agreement, including any extension years, exceed five (5) years.

The City of Stamford requests the appropriation of \$50,000: \$25,000 that the Connecticut Department of Transportation (CTDOT) and \$25,000 that the Stamford Downtown Special Services District (DSSD) has committed to provide for the STC Garage Mural project.

30. <u>REQUEST FOR APPROVAL OF 3rd AMENDMENT TO ORIGINAL CONTRACT BETWEEN THE CITY AND THE EPA'S LEASE OF SPACE-9TH FLOOR OF THE GOVERNMENT CENTER.</u>

The US Government (EPA) leases approximately 1,380 square feet of office space on the 9th floor of Government Center. The original lease was executed in March 2009. The original Term of the Lease was 10 years. The City amended that Lease in May 2010 by way of a Supplemental Agreement (1st Amendment) that extended the end-date to October 31, 2019. A 2nd Amendment was executed in September 2019 that gave the EPA an additional 5-year option and set the annual rent at \$66,373.31 with CPI escalations. The current lease term expires on October 30, 2024.

This proposed 3rd Amendment:

- Gives the EPA a 2nd 5-year option (to October 30, 2029).
- Removes the annual adjustments and sets the annual rent at \$71,191.45, yr 1; \$73,327.19, yr 2; \$75,527.00, yr 3; \$77,792.81, yr 4; and \$80,126.60, yr 5 (equates to a 3% increase each year).
- Adds certain additional Federal Acquisition Regulation (FAR) and General Services Administration Acquisition Regulation (GSAR) clauses for lease renewals.
