

2 & 3	Tree inventory update and other grants and initiatives.	Erin McKenna	Erin McKenna shared the status of the Stamford Tree Inventory. The inventory recorded every tree and tree bed in the city's rights-of-way. (This does not include parks, schools, or private property.) The consultant, Davey Resource Group, is currently

The inventory has identified about 2,500 planting opportunities citywide.</li> <li>The inventory identifies each tree, species, location, size, health, and condition. It also identifies empty tree pits and areas lacking trees.</li> <li>Consultants will be able to provide a preview of the data in Tree Keeper to this group in November.</li> <li>The City was also awarded a \$1M grant for tree planting, but the grant has not arrived yet.</li> <li>The Stamford Downtown Special Services District conducted a downtown street inventory last summer which is included in the citywide inventory.</li> <li>Bob Clausi presented the updated Inland Wetland and Watercourse regulations to be adopted by the Board of Reps which will extend the distance of the Board's review and permit area from 25 feet from an inland wetland to 50 feet.</li> </ul>		
4	Open Discussion on Goals and Outcomes of Working Group	All	The group discussed many on-going urban challenges including:  • street tree maintenance and funding;  • issues between public and private tree rights and benefits;  • coordination of tree planting and maintenance on state roadways;  • tree bed size;  • sidewalk disruption from growing tree roots, repair responsibility, and the use of flexible and pervious materials;  • tree health and invasive species;  • the need for more expertise in tree care and maintenance including the opportunity to provide specialized, career-oriented training especially with youth; and  • securing community involvement through information, education, and stewardship programs.

	Coordinate tree planting and maintenance with sidewalk repairs, replacement projects, and roadway intersection upgrades.

	Develop criteria to prioritize equitable, tree-planting decisions.
	Provide more public outreach and information on neighborhood projects to local residents, including with local faith-based organizations/individuals.
