#### **Project and Applying Entity Narrative Information**

#### Project Summary (Provide a concise comprehensive overview of the entire project and its key details.)

The City of Stamford has identified the need to upgrade the technological capabilities of its undercover surveillance criminal investigations. Currently, when our Narcotics, Detective, Youth or Patrol Units must conduct undercover surveillance criminal investigations on a suspect they are using outmoded handheld cameras that have had limited success in criminal proceedings in court. In major investigations such as underage sex offenses, fentanyl trafficking, and murder investigations the Stamford Police Department has been "borrowing" a surveillance van from the New England State Police Information Network (NESPIN) located in Rhode Island. Although the Stamford Police Department (SPD) appreciates the support from NESPIN, their van is not always available when needed, nor is it a feasible long-term solution to conducting major criminal investigations. To address this issue, the SPD has procured a van with local funding to be used in these types of investigations. This van must be equipped with appropriate technological surveillance equipment for the SPD to use. Through Bryne JAG funding the SPD proposes to contract with a qualified TBD vendor to purchase the surveillance equipment, have them install it in the SPD's van, and provide on-site training to the SPD in the use of the equipment. This project will significantly enhance the quality of undercover criminal investigations, as well as significantly enhance the quality of evidence collection, with the intended outcome of better conviction rates of dangerous criminals in court proceedings.

## (2) Project Justification (Provide a needs statement that includes details on the location and target population that will be impacted by the project. If underserved individuals will be impacted please provide specific details.)

This project addresses the urgent need to significantly enhance the technological capabilities of the SPD in conducting undercover surveillance operations in major criminal investigations. Currently, the SPD investigative units are using outmoded handheld cameras for evidence collection in these types of investigations. This antiquated form of evidence collection has resulted in less than successful conviction rates in court proceedings. For major cases, many of which impact underserved populations, such as underage sex offenses, narcotics/fentanyl trafficking, illegal gun trafficking and murder investigations, the SPD has been "borrowing" a van from a law enforcement partner located in another state. This is not a sustainable strategy to improve the efficiency and effectiveness of important criminal investigations. In order to improve evidence collection and efficiency of criminal investigations, the SPD has used local funds to purchase a van to be used for surveillance operations in these cases. The SPD is requesting to utilize Bryne JAG funds to contract with a qualified TBD vendor to purchase enhanced surveillance equipment (4- camera, multi-battery, full 360 view system with up to 3 days of system power and storage), and for the the vendor to install the equipment in the van and provide on-sight training to relevant SPD personnel on the use of the equipment. This project will improve evidence collection in support of criminal prosecution in the areas of illegal narcotics, sex offenses, financial crimes and homicides. Absent advanced equipment, many of these cases may not be prosecuted or criminals may be released due to insufficient evidence. The project will benefit victims in Stamford, and throughout the region as the SPD will conduct joint investigations with area law enforcement partners, from all demographic and ethnic groups including those from traditionally underserved populations. This project will also benefit prosecutors by providing them with quality evidence that can secure conviction of perpetrators of these major crimes. The equipment requested in this project will only be used in major criminal investigations and not for any general type of public safety activities.

The Project Manager will be Lieutenant Seth O'Brien of the Narcotics & Organized Crime Unit. The surveillance equipment will be utilized in a variety of criminal investigations such as underage sex offenses, fentanyl trafficking, and murder investigations which all fall under the umbrella of this unit. Lieutenant O'Brien has over 20 years of experience working in the both the Detective, Naracotics and K9 Units. Lieutenant O'Brien will be assisted by Detective Michael Spinosa. Detective Spinosa works closely with all units conducting undercover criminal investigations and is currently the SPD's liaison with NESPIN in Rhode Island who currently works with us in utilizing their surveillance van. Detective Spinosa will be instrumental in providing "boots on the ground" data for reporting and evaluation purposes. The City of Stamford will contract with a qualified vendor to purchase the equipment and install it in the SPD's newly purchased surveillance van. The selected vendor will also provide on-site training to select SPD personnel in the use of the equipment. The TBD vendor will also provide a warranty for the surveillance equipment.

The City of Stamford Grants Office will be responsible for monitoring the project and ensuring compliance with OPM policies as well as City of Stamford Procurement policies. The Grants Coordinator for the City of Stamford, Joseph Hickey will be responsible for submitting all programmatic reports and ensuring overall grant compliance. The Grants Account Analyst, Emmanuel Bouchotte will be responsible for submitting all financial reports and ensuring compliance with all financial aspects of the project. Both of these individuals have past experiences working with Grantium.

The City of Stamford will contract with a qualified To Be Determined (TBD) vendor to purchase the surveillance equipment and install it in the Stamford Police Department owned surveillance van. The selected vendor will also provide on-site training to relevant Stamford Police personnel in the use of the equipment. The City of Stamford will follow all Byrne JAG as well as established City of Stamford procurement polices in selecting the vendor. The City of Stamford obtained a price quote from a qualified vendor solely for the purpose of constructing a budget for this proposal.

The anticipated outcome of this project is that enhanced surveillance equipment installed in a van will significantly improve the efficiency and quality of undercover criminal investigations conducted by the SPD and in joint criminal investigations with other municipal law enforcement agencies. The improved quality of investigation will result in better evidence collection to be used in criminal cases, with the goal of increased convictions of dangerous criminals. The performance measures that will be utilized to track the effectiveness of the project is to measure the degree of increase in the quality of evidence obtained, and, ultimately, in the success rate of prosecution in criminal cases.

#### II. Project and Applying Entity Narrative Information

#### (1) What state-level criminal justice needs or issues do you plan to address with Byrne JAG funds?

The most basic primary responsibility of law enforcement is to protect the public from criminal activity and maintain law and order. The Stamford Police Department (SPD) is the sole law enforcement agency responsible for maintaining public safety in Stamford. One of the most critical responsibilities is to prevent major criminal activity whenever possible, and when it does occur, is to conduct professional efficient investigations to capture and prosecute those responsible. This project seeks to significantly enhance the quality and efficiency of major criminal investigations through sophisticated and thorough undercover surveillance operations on suspects engaged in major criminal activity. Through this project, the SPD seeks to purchase advanced equipment (a four camera, multi-battery, full 360 view system with up to three days of system power and storage) to utilize in major criminal investigations such as underage sex offenses, narcotics/fentayl trafficking, illegal gun trafficking, and homicide cases. This equipment will be installed in a van purchased by the City of Stamford through a separate funding source, to conduct the surveillance operations on criminal suspects. The purchase of the van demonstrates the commitment the SPD has to enhance its criminal investigative capabilities. The enhanced equipment will significantly enhance evidence collection capabilities and provide prosecutors with better quality of evidence to pursue convictions of dangerous criminals in court proceedings. We anticipate that this will result in securing a greater number of convictions of dangerous criminals. This project will benefit victims and potential victims in Stamford and throughout the surrounding region as the SPD will utilize these assets to conduct joint investigation with area law enforcement partners.

## (2) What is the evidence or data that supports the impact of the program for which you seek to receive Byrne JAG funding?

This project seeks to address the need to significantly enhance the technological capabilities of the SPD in conducting undercover surveillance operations in major criminal investigations. Currently the SPD is utilizing handheld cameras for evidence collection that has had limited success in court proceedings. Enhanced equipment is vital to collect sufficient evidence to successfully prosecute major criminal targets. For example, in order to prosecute illegal drug/gun "buys", law enforcement is required to have audio/video evidence of the illegal transaction. Absent this evidence, law enforcement is unable to charge the suspect. Real-time surveillance is a vital component for documenting illegal transactions, identifying key individuals in drug/gun networks, and capturing incriminating evidence that can be used by prosecutors in court. Absent discrete observations, which the items requested in this proposal will allow, it is extremely difficult to gather the required proof to ensure a successful prosecution, particularly since most large-scale drug/gun operations are highly secretive and transient, making direct intervention risky and less effective. The equipment requested in this proposal will have enormous benefits in professionalizing major criminal investigations and allow the SPD to capture the required evidence to successfully prosecute dangerous criminals.

#### (3) What expenses are associated with this project or program?

The City of Stamford will contract with a To Be Determined qualified vendor to purchase equipment, have it installed in a city-owned van, and provide on-site training to a few SPD Detectives on the use of the equipment. These Detectives will train additional investigative personnel in the use of the equipment. The City of Stamford will follow all Bryne JAG and established City of Stamford procurement policies on selecting a vendor. Since we will be contracting with a vendor, the costs have been placed in the Procurement Contract Budget line item. The City of Stamford obtained a Quote from a qualified vendor for cost estimates for this proposal. The following is a list of the items on the quote:

#### (4) How will Program Impact be Measured?

The SPD will measure the impact the upgraded equipment has on the efficiency and quality of major criminal investigations. This will include an evaluation on the quality of evidence collected, the number of cases that are brought to court, and the number of cases that are successfully prosecuted. The SPD will also evaluate the change in how criminal investigations are conducted pre- and post equipment, to gauge what other factors may increase the efficiency of operations. The program will also be measured by the number of joint investigations between the SPD and partner law enforcement agencies in the region that resulted in successful prosecutions in these jurisdictions. The program will also be measured by the number of SPD detectives trained in the use of the new technology with the goal of having personnel in all investigative units trained. We anticipate that the program will result in better quality of evidence and increased prosecutions of dangerous criminals.

#### (5) How will this project be sustained after the expenditure of any Byrne-JAG funds received?

The City of Stamford will sustain the project after Bryne-JAG funds have been expended by assuming the cost to maintain the surveillance equipment and all applicable licensing costs. Additionally, the City of Stamford will assume all costs for maintaining/repairing the surveillance van in which the surveillance equipment will be installed. Although the van has been procured through a separate funding source, its continued uses is paramount to the success of this project. Also, the City of Stamford Grants Office constantly researches for other local, state, federal, foundation and private funding sources to sustain grant-funded projects.

#### (6) What Financial Systems Would be Used for Grant Management?

The City of Stamford utilizes an Oracle based financial system. This system is capable of tracking grant-related expenditures separate from operational and capital expenditures. Our financial system also prevents co-mingling of grant expenditures. The City of Stamford has a long history of successfully completing and Closing Out grant awards from many federal and state agencies including OPM. City of Staff Grant staff also have experience working with Grantium in past OPM awards.

(7) Will any of the Byrne JAG funds be used by a state or local government to reduce state or local funds for an activity, specifically because federal funds are available (or expected to be available) to fund that same activity? There are no state or local funds already allocated for any items requested in this application. The City of Stamford Grants staff is familiar with federal and state regulations prohibiting supplanting. The City of Stamford is the 16th most diverse city in the nation. In 2022, Stamford hired its first Director of Diversity, Equity, and Inclusion. This proposal will benefit efforts to advance equity in the quality of life for all people in our community and region equally, and provide equity in law enforcements capabilities to get "bad actors" removed from our streets.
