

# Significant Tasks Remaining for FY 2023 Audit


- Provide complete Trial Balance
  - Several technical adjustments have taken more time than expected due to complications in Oracle. Multiple areas of clean-up required (retainage, IBNR, TIF funds, CDBG)
  - Capital Funds 3000 and Grants 2800 Project tie out to PPM (subledger system) took more time as well. We experienced additional work - roll-forward is going to be an issue.
- Complete Fixed Assets update
- Complete remaining schedules for notes and supplemental information
- Provide selections for auditors, address questions

Management continues to believe that we will be able to complete these tasks in time to produce an ACFR before 12/31/2024.


















