## <u>Discussion With Municipal Valuation Services LLC</u>

The meeting started with Mr. Kerin's brief introduction of himself and the background of the valuation company he represents. He then went over how they collect data and the generally accepted methods they use to determine market values of the properties during the revaluation process. Mr. Kerin added that other factors such as condition of the property could affect the value of the property. He also stated the topographic changes made previously would stay with the assessment but other overrides were removed during revaluation.

# **Discussion With Stamford Tax Assessor**

Mr. Stackpole first went over data and statistics of the properties in Stamford. He then reviewed and provided additional details of the revaluation process. Mr. Stackpole also went over the Sales Books which Board Members can use to support Assessor's values during the hearings. He then passed around a field card for the Board Members to look at and pointed out some sections of the field card that Board Members should pay attention to. Mr. Stackpole confirmed that inspectors will be available on hearings and deliberation dates to assist with any questions that may arise.

# **Board Members Update**

Mr. Sessa gave an update on all the board members' terms as follow:

- Ralph Loglisci expired as of December 2017 and has not yet been re-appointed. Per the City of Stamford Charter, he was allowed to serve for an additional six months.
- R.W. Leyden term expires at the end of 2018
- Larry Ginsberg and Richard Agatstein terms will expire at the end of 2019
- George Sessa term will expire at the end of 2020

George Sessa was voted unanimously to remain as Chairman. Sue Greene will remain as Clerk of the Board through March 31, 2018. The Board Members by unanimous vote appointed Prisca Lin as Clerk of the Board starting April 1, 2018.

## **Procedures For Hearings**

All board members were advised that appellants, except for the attorneys, must be sworn in or affirmed before the hearings begin.

#### **Documentation Requirements**

Since Mr. Agatstein is new to the Board, the rest of the Board Members reviewed the documents that may be supplied by the appellants at the hearings. Mr. Sessa advised that if sales data in the neighborhood are presented, Board Members need to make sure they are comparable in terms of style, size, grade, etc. He also reiterated that it was the appellants' responsibilities to present evidence to support their appeals during the hearings, not the Board Members to prove for them.

Mr. Sessa suggested Mr. Agatstein meet with one of the inspectors to go over the information on the field card. A meeting has been scheduled for March 1, 2018 at 11 A.M.

## Commercial Parcels with over One Million dollars assessment

Per C.G.S. §12-111, the Board may elect to not hold hearings for Commercial Parcels with assessed values greater than 1 million dollars. Motion was made by George Sessa to not hear, seconded by R.W. Leyden. All were in agreement.
