- E. Mark Wetzel of Fiduciary Investment Advisors – Quarterly report.

Mr. Wetzel reviewed the quarterly report with the Trustees and made some recommendations. There will be rule changes to Money Market accounts starting October 2016. Mr. Wetzel suggested moving the money market accounts into a government fund where you won't have to worry

about restrictions and fees to take money out. Mr. Wetzel reviewed the Cash Cash Flow Worksheet to raise cash for next quarters pension payments.

Mayor Martin would like to discuss the Money Market rule changes at the May meeting.

Mayor Martin made a motion for the paperwork for Metropolitan West lower fee rate. The motion was seconded by Mary Lou Rinaldi. The vote was 6 – 0 unanimous.

Mayor Martin made a motion to move all of Westfield Capital into T. Rowe Price. The motion was seconded by Joseph Caruso. The vote was 6 – 0 unanimous

Mary Lou Rinaldi made a motion to move \$10 million from GMO to Black Rock. The motion was seconded by Joseph Caruso. The vote was 5 in favor and 1abstention. The Mayor abstained.

Mayor Martin made a motion to have Clemon Williams sign off on Templeton Global Bond reduced fee paperwork. The motion was seconded by Mary Lou Rinaldi. The vote was 6 – 0 unanimous.

Mayor Martin made a motion to raise cash for next quarters pension payments To take \$1,775,000 from Metropolitan West Return Bond I, \$900,000 from Black Rock Strategic Income Opportunities Class Ins., \$1,075,000 from Westfield Capital Large Growth. The motion was seconded by Mary Lou Rinaldi. The vote was 6 – 0 unanimous.
