

### CITY OF STAMFORD POLICEMEN'S PENSION TRUST FUND BOARD

A Regular Meeting of the Stamford Police Pension Board of Trustees was held on Tuesday, July 13, 2021 at 5:30 p.m.

Present at the meeting were Lt. Michael Noto, Officer Jessica Bloomberg, Commissioner Frank Mercede and Mr. Michael Berkoff (via telephone). Commissioner Timothy Abbazia was absent. Also present were Thomas Deegan of Clearshares, LLC; Attorney Anthony Macleod and Donna DeVito, Recording Secretary.

The meeting was called to order at 5:35 p.m. by Lt. Noto.

### **Approval - Meeting Minutes from June 8, 2021**

Lt. Noto reported that all retirees are to receive an additional \$100.00 in their July check as per the Police Contract obligation for supplemental medical reimbursement. This is a yearly obligation as per 1968 Contract language.

#### **CIC**

#### **Fund Review**

Tom Deegan distributed the monthly financial statement for June 2021 and a Flash Report for June 2021 that included the Fund's asset allocation and 12 month rolling graph. He reported that as of June 30, 2021, the Fund's assets were \$233,175,116, the monthly performance was 0.74%, quarter performance to date was 4.01%, year-to-date performance was 7.09% and fiscal year performance to date was 18.15%. He reported that overall performance of the Fund was strong as Equities, Fixed Income, Real Estate and the Alternative investment portfolio continued its steady growth. The DOW Industrials, the S&P 500 and the NASDAQ continued to move higher and set new records. He noted that Delta Capital settled its first lawsuit which distributed of \$600.000 to the Fund. Mr. Deegan felt that the Pension Fund was in a good place and did not recommend making any measurable changes to investments at this time.
