1. The meeting was called to order by Committee Chairman Karp at approximately 5:32 p.m.

2. Review and Approval of July 12, 2021 Meeting Minutes.

Commissioner Ortelli moved to approve July 12, 2021 Meeting Minutes.

3. CT DEEP LWRD License Application Pre-Submission Consultation Form HMC - Anya Kishinevsky, 80 Davenport Drive, Stamford, CT.

Applicant seeks a DEEP permit to authorize placement of additional stone along the existing revetment crest and place fill to level out low spots in the lawn to be coincident with existing high points and adjacent property grades to the north and south. The work includes placement of some revetment stone waterward of the Coastal Jurisdiction Line (CJL). Portions of the work have already been completed including the stone placement and re-grading.

Steve Sternberg, RACE Coastal Engineering, was present to explain the project and answer the Commissioners' questions.

Commissioners noted the HMC had previously expressed no objection to the proposed project when it was submitted to the HMC and DEEP in the form of a Certificate of Permission application. Mr. Sternberg stated that since that time, the proposed project has not changed but DEEP has determined that a full DEEP permit is needed to authorize the work and issue after-the-fact approval of the work already completed waterward of the CJL.

Commissioner Ortelli made a motion to recommend to the SHMC a finding of no objection to the pre-application plans being included in a permit application to DEEP, with the understanding that this expression of "no objection" should not be construed as a precedent for the SHMC to support after-the-fact approval of previously completed but unauthorized work in other instances, and that the SHMC reserves its right to continue to review the proposal.

4. CT DEEP LWRD License Application Pre-Submission Consultation Form Shellfish Commission - Anya Kishinevsky, 80 Davenport Drive, Stamford, CT.

This is the same project as discussed in Item No. 3 above. Insofar as DEEP is now requiring the applicant to submit an application for a DEEP permit to approve this project, pre-application review with the SHMC acting in its capacity as the Stamford Shellfish Commission is also required. Commissioners agreed there would appear to be no impacts on shellfish resources and therefore, the same motion as for Item No. 3 is appropriate.

Commissioner Ortelli made a motion to recommend to the SHMC a finding of no objection to the pre-application plans being included in a permit application to DEEP, with the understanding that this expression of "no objection" should not be construed as a precedent for the SHMC to support after-the-fact approval of previously completed but unauthorized work in other instances, and that the SHMC reserves its right to continue to review the proposal.

Before beginning the discussion of the *Old Business* items, Chairman Karp reported on the status of Zoning Board Application #221-01 - Sound Beach Landing LLC, 40 Signal Road, Stamford, CT - Text Change; and Zoning Board Application #221-02 - Sound Beach Landing LLC, 40 Signal Road and 0 Thread Needle Lane, Stamford, CT - Map Change. Although new information has been provided by the applicant, it was not received in time to place this application on the agenda for tonight's meeting. Comments by Commissioners, the applicant's representative, and members of the public concerned only the process and schedule for review. It was reported by the applicant's representative that a Planning Board Public Hearing on the proposed Master Plan change is scheduled for August 31, 2021. Commissioners expressed concern that this schedule will not provide adequate time for review by the SHMC. Commissioner Ortelli will contact the Planning Board to express SHMC's concern.
