Sonya mentioned the intersection of Henry Street & Atlantic Street emphasizing it is difficult to make a left on Henry when cars are parked in front of the barbershop. When there are no parked cars making the left turn is much easier

**Ted Ferrarone** gave an update on the Henry Street Homes in which 118-120 Henry Street needs the city to sign off on the rest of the permit in order to continue the rehabilitation

A new restaurant is going into the old Dinosaur BBQ site called Tequilla Escape

**Terry Adams** asked Ted to look into one of the residents on 200 Henry Street throwing paper out the window causing unnecessary debris to pile up along the street scape

**Marlene Rhome** stressed the smells coming from O& G and the sewage plant over on Canal Street. Tom mentioned reaching out to SWPCA and it was also mentioned that the Board or Representatives are trying to get air monitoring.

A resident comment was made about Paisano and the illegal activity that is taking place on their site which is in violation of planning and zoning (body work, changing oil, cars parked on the street at all hours). Suggested this gets looked into since it is a community nuisance.
